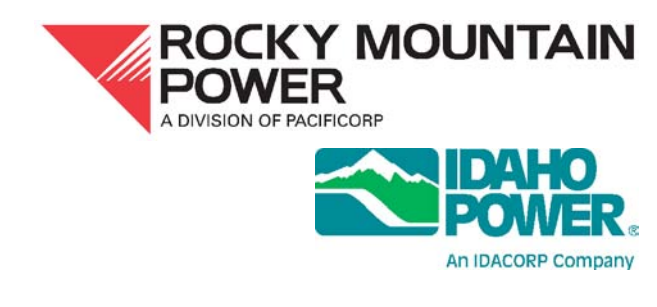


GATEWAY WEST TRANSMISSION LINE PROJECT
